(1) Queen's University – Application for Noise Exemption – Sports Fields Located at the Corner of Sir John A. Macdonald Boulevard and Johnson Street

THAT Queen's University be granted an exemption from Noise Control By-Law 2004-52, Schedule "A", Section 7 and Schedule "B", Activities 4 & 15 to permit amplified sound, game whistles, yelling, shouting, hooting, whistling, singing or the playing of musical instruments, including percussion instruments subject to the following conditions:

1. Fields located at the corner Sir John A. Macdonald Boulevard and Johnson Street

- a. Monday to Thursday between the hours of 9:00 a.m. and 11:00 p.m.
- b. Friday to Sunday, including statutory holidays, between 9:00 a.m. and 9:30 p.m.
- c. 10-15 minutes will be permitted after end time of the exemption to allow participants to safely leave the fields.
- d. Single use occurrences from Friday to Sunday, including statutory holidays between the hours of 9:00 a.m. and 11:00 p.m. to a maximum of 24 days in a calendar year.
- e. Marching bands and the use of all percussion instruments and spectator noisemakers are prohibited at all times.
- f. Amplified noise will be permitted between 9:00 a.m. and 9:00 p.m. for game and hosting announcements only and will not exceed 5 minutes in duration at any one time.

2. Richardson Stadium

- a. Monday to Thursday between the hours of 9:00 a.m. and 11:00 p.m.
- b. Friday to Sunday, including statutory holidays, 9:00 a.m. until 9:30 p.m.
- c. 10-15 minutes will be permitted after the end time of the exemption to allow participants to safely leave the fields.
- d. Single use occurrences from Friday to Sunday, including statutory holidays, between the hours of 9:00 a.m. and 11:00 p.m. to a maximum of 24 days in a calendar year.
- e. Amplified sound, marching bands and the use of all percussion instruments, and spectator noisemakers will only be permitted when a single Occurrence Exemption is utilized.

3. Queen's University will communicate in the following manner:

- a. Proactive and annual communication will be provided to all user-groups with regard to minimizing noise levels.
- b. Signs will be posted to remind organizers, participants and spectators to minimize noise.
- c. Noise clauses will be inserted into all field-use Agreements. A range of sanctions will be imposed, including the termination of Agreements for groups that do not honour contractual obligations.

4. Queen's University will schedule their fields in the following manner:

- a. Eliminate all activity prior to 9:00 a.m.
- b. Maximize activity on other fields further from residents and scheduling of "quieter" activities in later hours.
- c. Limit competitive games and activities that attract a crowd to end prior to 9:00 p.m.

5. Queen's University will proactively monitor their field in the following manner:

- a. Queen's Athletics & Recreation facility staff will conduct routine field audits to proactively monitor and address issues of noise.
- b. Queen's will establish a dedicated call-in number for residents to register any noise concerns.
- c. All complaints will be responded to immediately by members of Queen's Athletics & Recreation facility staff visiting the field to investigate.
- d. Violations of the terms of the exemption will result in a range of sanctions being imposed, including the possibility of denial of future access to the field.
- e. The contact number for noise concerns will be posted prominently on the Queen's web site and communicated directly to neighbourhood residents.
- 6. Queen's University will perform an Engineering Noise Study to examine the noise propagation from the fields during activities until the fall and will provide City Staff with a copy of the study.
- 7. Queen's University will work with City Departments to determine the most effective noise reduction recommendations resulting from the Engineering Noise Study.
- 8. Queen's University will report all noise issues to the City of Kingston's Manager of Licensing & Enforcement, within 24 hours of Queen's receiving any direct complaints.

For the purpose of the 'E.441' zone, the following definition shall apply:

BEDROOM shall mean any room within a residential unit that is suitable to be used as a sleeping room under the <u>Ontario Building Code</u>, and which for greater certainty does not include

- (i) Common areas open to all occupants of the unit;
- (ii) Areas used for sanitary (such as washroom) or cooking purposes (such as a kitchen), and
